2.0 Land Acknowledgement

Assiniboine Community College campuses and the offices of the ACCSA are located on the traditional territories of Treaty No. 1 and Treaty No. 2, and the shared traditional lands of Cree, Oji-Cree, Dakota, Dene and Anishinabek/Ojibwe peoples, and the homeland of the Métis nation.

4.0 Old Business

4.1 MAPSS Update

- Vote taken and ACCSA accepted as a member.
- ACCSA representative to start attending meetings soon.
- Bridges invited members to keep an ear out for provincial issues that may affect students so they can be brought to MAPPS meetings.

4.2 Crossroads Design Update

- Bridges gave recap.
- Bridges encouraged members to bring ideas as well as to engage students for their ideas
- Student space ideas shared by Cinq-Mars are as follows:
 - Braille options for written material in the space, e.g., for land acknowledgement.



- Indents or outdents along the walls for a guide for the blind
- Arbour inspired architecture that showcases indigenous welcomeness to celebrate
- Rainbow lighting for the stage area which will accentuate the feature and visually represent inclusivity for LGBT2SQ+ safe space. Members liked ideas.
- Genaille (Guest) asked about ways braille could be used to describe the mural.
- Cinq-Mars directed students to check online for other ideas.
- Cing-Mars would like to see diversity reflected in the new spaces.
- May reminded SAC that the boardroom fixtures would also need to be chosen. e.g. white board vs blackboard, if a television was wanted, tables etc.
- May reminded the SAC that they could tap into their well-experienced Accessibility Representative on Council who could contact other students and ACC staff to see what else can be accomplished from an accessible lens.

5.0 New Business

5.1 By-Election Updates

- May informed the SAC that today was the beginning of nomination. Email has been sent out to students about the positions.
- Bridges stepping down and will be running for president. His last day will be on Friday November 26th.
- There are currently 7 positions. Positions listed:
 - President
 - Vice President Governance
 - Parkland Chair
 - LGBT2SQ+ Representative
 - Adult Collegiate Representative
 - M.I.C.A. Representative
 - Business Presentative
- Nominations need to be in by end of the week (Friday November 26th).

5.2 Council Reports Update

- Bridges Reports will be going out every 2 weeks.
- Reports will help track work or concerns of members so executives can offer support and keep goals on track.
- Executives' reports will be weekly.

5.3 Coat Drive Update by Executive Director

 May-reached out to Assiniboine International and they are willing to partner with the ACCSA.



- Email to connect everyone will be sent out tomorrow to get everything started. Email will only be going to volunteers.
- Volunteers to step up with planning and execution with Assiniboine International.
- Nault asked if they were only collecting coats? May toques, hats and mitts too, but main focus is on coats.

5.4 Council Professional Development Updates

a. Mental Health First-Aid Training Proposal

- Parkinson gave an overview on the briefing note provided about the professional development options outlined.
- 1st option The Inquiring Mind Post-Secondary is a 4hr session, \$1,600
- 2nd option is Mental Health First Aid (MHFA), \$3500, more intense but more practical for leaders that work with students.
- Decision needs to be decided 6 weeks in advance. Parkinson will be looking at the second week of January 2022, moving forward.
- Teichroeb inquired about where in the budget this training would come from.
 May provided a snippet of the ACCSA Budget and noted that the most
 appropriate place would be within the Governance and Meeting Expense
 section of the Budget. There is currently just over \$5000 available.
- Events budget, \$11,000, also available because of COVID which results in less events expenditure. This account less appropriate based on the account's design as this professional development is not open to students.
- Teichroeb asked if budget can sustain all professional development offerings. Bridges things can be moved around once there is explanation.
- May gave vision for events budget.

MOTION: Be it resolved that the ACCSA allocate \$3500 + tax to provide the Mental Health First Aid training sessions for the SAC

Moved by Nault, Seconded by Teichroeb. Motion Carried.

b. LGBT2SQ+ Training Dates in January

- Parkinson noted that SERC's schedule fills up very quickly, and as a result the ACCSA is hoping to schedule this for January 2022.
- Parkinson gave a brief overview of the training. Roughly a 2-3 hour session that could potentially be done on the evenings of school days, or also on weekends.
- Parkinson will commit to setting a date for the MHFA training first and will book SERC second.
- Brown will LGBT2SQ+ training be from the events budget if open to all? Bridges yes it will.



5.5 Goal Mapping

- Executives have goals which are actioned through committees.
- Goals mapping helps offer more structure.
- Bridges asked members about what they wanted do in their positions.
- Members were placed into break out rooms to brainstorm.

- Nazar Asked about when the social committee would meet. May Engagement hasn't met yet, we're working on it this week.
- Bridges indicated that from the breakout he learned that persons want more in-person interactions.
- Nault reminded the SAC of a wellness event Wellness Chat. To happen next week. May asked for information to ensure they are promoted.
- Genaille spoke on Parkland's wellness event December 1st.
- Cinq-Mars -Spoke to SAC about general engagement of students. Teichroeb cited that is also required of SAC.
- Benn- requested a whiteboard in student lounge to promote events. Cinq-Mars
 indicated that the SA currently short staffed and therefore unable to update boards but
 will soon be better with new staff.
- Nazar Asked about study areas. She suggested that it may be good to post on Instagram so students know where they can go.
- May recommended that student representatives are the best persons to use on social media to talk about student spaces. May then invited students to submit articles for Student Focus blog.
- May and Bridges to invite Karleigh Paul, Marketing & Communications Coordinator, to a meeting to educate SAC on marketing options.
- Genaille asked about private chat. Bridges gave briefing about current chat.
- Members suggested to check out Gather Town. May to send information to SAC.
 Members like idea. Bridges suggested Facebook group.
- Genaille indicated that he feels isolated.
