- o More meaningful college experience.

- Cons of Common Block:
 - o Can't accommodate for practicum and work experience.
 - o Apprenticeship Manitoba students may have challenges, same for nursing due to program hours requirement.
- 90min block preferred so students aren't rushed.
- Tuesdays/Wednesdays/Thursdays preferred.
- Cinq-Mars will it be sent to Student Attendance Subcommittee (College Council). May -No Deanna (& Learning Leadership Council). It may however eventually be seen by subcommittee.
