Terms & Conditions

This agreement outlines the terms between the **Assiniboine College Students' Association (ACSA)** and the participating business/discount provider (hereafter referred to as "The Business") under the Prairie Perks discount program.

ACSA Responsibilities

The Assiniboine College Students' Association (ACSA) agrees to provide participating Prairie Perks partners with all necessary promotional materials within 30 days of the commencement of this contract. This includes Prairie Perks decals, examples of valid student ID cards bearing the Prairie Perks symbol, and informational content explaining the program.

ACSA will actively promote participating businesses on our website under our Prairie Perks business directory, on our business directory on the ACSA App, on our social media, and posters around our campuses.

Prairie Perk Partners will receive first access to opportunities to showcase their business during Welcome Weeks and other student events coordinated by the ACSA throughout the year through sponsorships or prize donations.

In the event a business wishes to withdraw from the program, ACSA will process the termination request and provide written confirmation within 30 days. Upon withdrawal, the business will be removed from the Prairie Perks directory and all promotional listings.

Business Partner Responsibilities

The Business agrees to honor the discount listed in this agreement for all current Assiniboine College students who present a valid student ID with the Prairie Perks symbol. The discount must be provided at the time of transaction, and the business reserves the right to decline the discount if a valid ID is not shown.

The Business agrees to prominently display the Prairie Perks decal at their physical location, indicating their active participation in the program.

By signing this agreement, the Business grants ACSA permission to use the business name, logo, and a brief description of services or products in all related Prairie Perks promotional materials. This includes but is not limited to our website, our app, social media and/or posters.

The Business commits to maintaining a discount of its choice while remaining a partner. If they choose to change the discount they are offering at any point, written notice will be provided to the ACSA so the discount can be updated on the ACSAs' website/app.



The Business agrees to maintain respectful and fair interactions with student customers. ACSA reserves the right to review or terminate this partnership if complaints or concerns regarding the business' conduct are brought forward.

Termination of Partnership:

Businesses may terminate this partnership at any time by completing the membership cancellation form provided on the ACSA website.

If any of the above terms and conditions are not followed by ACSA and/or the business, the parties reserve the right to determine this agreement null and void.

Agreement and Authorization:

This Partnership Agreement shall be in effect upon signing. I/we have read, understand and agree that all terms/conditions outlined on this Partnership Agreement form are considered valid components of the Partnership Agreement.
